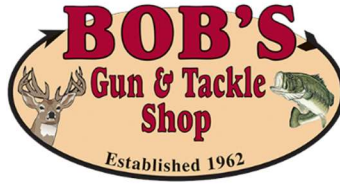

TRANSFER FEES & POLICIES

NFA TRANSACTION FEES

(Applies to NFA Transfers & NFA Sales)

One-Time Profile Setup w/ Fingerprinting & Photo: \$20.00

Can be reused for future NFA purchases from Bob's Gun & Tackle Shop

Fingerprints/Photos Remain Property of Bob's Gun & Tackle Shop and are not available to customer

Optional On-Site NFA Trust Creation (Notarized) w/ 2 RPQs: \$125.00

Each Additional RPQ Beyond 2: \$5.00

TRANSFER FEES

Non-NFA FFL Transfer (Bought Elsewhere & Shipped Here for Pickup): \$65.00 for the 1st firearm. \$25.00 for each additional firearm on the same 4473.

NO DISCOUNT ON FEES IF PURCHASING NON-NFA ITEM AND NFA ITEM ON SAME 4473.

Storage Fee: \$3 per day begins to apply after 14 days of being contacted for pickup

****NO TRANSFER FEE IF PURCHASED FROM BOB'S GUN & TACKLE SHOP****

NFA Transfer (Bought Elsewhere & Shipped Here for Pickup): \$110.00 per item

Storage Fee: \$3 per day begins to apply after 14 days of being contacted for pickup

****NO NFA TRANSFER FEE IF PURCHASED FROM BOB'S GUN & TACKLE SHOP****

POLICIES

-No sales or transfers of SBRs. SBSs, grenade launchers, machineguns, destructive devices, and select other items. *Bob's Gun & Tackle Shop reserves the right to refuse transfer of any item for any reason without explanation.*

-Delivery notification does not indicate that your item is ready for pickup. Bob's Gun & Tackle Shop will call you when your item has been received and processed. Please do not come in until we call you, as your item will not be available for pickup.

-FFL Transfers or NFA Transfers: If you are delayed, denied, or otherwise wish not to take possession of the item(s), you are still responsible for all transfer fees & return shipping.

-If ATF Form 4 has been completed (submitted or not) and you decide you no longer want that item, Bob's Gun & Tackle Shop will issue refund of price paid on NFA item less \$25.00 restocking fee. NO REFUND ON PROFILE SETUP, FINGERPRINTING AND PHOTO OR TRUST CREATION FEES.

-NFA items and all applicable fees must be PAID IN FULL prior to submission of ATF Form 4.

-FFL Transfer fee must be paid in full prior to starting ATF Form 4473.

-You must **begin** paperwork within 14 days of being contacted by us. Otherwise, a storage fee of \$3 per day begins to apply after the 14th day. After 30 days, item may be returned to sender or surrendered to law enforcement as abandoned. Customer is responsible for all associated expenses.

-Special orders for all NFA items require a minimum of 50% down and the remainder must be paid-in-full prior to submitting ATF Form 4.

-No layaways on NFA items.

-Bob's Gun & Tackle Shop must receive a PROCEED response on NICS background check in order to transfer firearm. Bob's Gun & Tackle Shop opts out of the Brady Act.

-NICS background check is required for every firearm sale/transfer. Bob's Gun & Tackle Shop will initiate a NICS background check for all firearm sales/transfers regardless of whether or not you have a CPL or LTP.

-If purchasing a firearm and NFA item on the same ATF Form 4473 and you receive a NICS delay or denial, you may **not** take possession of the NFA item even though you previously received ATF approval for it. The NICS background check overrules ATF approval in this scenario.

-No sales to non-Michigan residents. We are happy to ship your item to an FFL dealer in your state (for a fee).
